## **SHOW HOURS:**

SATURDAY, OCTOBER 3, 10:00 A.M. -6:00 P.M.

SUNDAY, OCTOBER 4, 1:00 P.M.-5:00 P.M.

**SET UP/TAKE DOWN:** BOAT SHOW and OUTDOOR EXHIBITORS SET UP WILL BE ALLOWED ON FRIDAY, OCTOBER 2nd FROM 9:00 am to 5:00 pm. EXHIBITORS MUST NOT REMOVE EXHIBITS UNTIL CLOSING ON SUNDAY, OCT.5th AT 5:00P.M. (NO LATE ARRIVALS WILL BE ACCEPTED DUE TO PORT HOURS AND SECURITY)

**PAYMENT:** PAYMENT IN FULL IS REQUIRED WITH APPLICATION. FEE IS NON-REFUNDABLE.

**SECURITY:** SECURITY WILL BE PROVIDED AT THE NORTH CAROLINA STATE PORT BEGINNING FRIDAY, OCTOBER 2nd FROM 9:00 AM TO 5:00 P.M. SECURITY WILL BE AT THE PORT FROM 5:00 PM ON FRIDAY UNTIL SUNDAY, OCTOBER 4th, AT 5:00P.M. ROVING SECURITY WILL BE PROVIDED DURING THE OFF HOURS OF THE FESTIVAL.

- Boat exhibitors agrees to display only new, unused current- model- year boats and marine related products. Exhibitor will not display any product without the endorsement or approval of the manufacturer. Exhibitor represents that it has full authority and all approvals necessary to display and sell its products at this show.
- Exhibitor agrees that show management may remove any exhibits that it determines are of a disruptive, objectionable or inappropriate nature.
- Exhibits must be staffed during all show hours.
- Exhibit removal prior to the final day's close of the show is strictly forbidden.
- Exhibitors may not sublease their space.
- Exhibitors may not utilize any form of recreational vehicle or trailer as an office or a residence for the festival boat show.
- The Show Management has full power in the interpretation and enforcement of all terms, rules and regulations and full power to establish other rules and regulations considered necessary for the proper conduct of the show.
- All exhibitors will be notified in writing of acceptance within 2-3 weeks of receipt of application.

**LIABILITY:** Neither The North Carolina Seafood Festival, Inc., The Town of Morehead City, The North Carolina State Port nor their representatives, nor their Directors, Officers, Employees, or Agents (herein collectively "the said parties") shall be held responsible for any injury to Exhibitors, or their employees, or guests, or visitors while within the confines of the space or spaces contracted for by the Exhibitor, or while on any boat or boarding device thereto which the Exhibitor has in the water at the show; nor shall said parties be liable for the loss or damage to any goods from any cause whatsoever while the same are in transit to or from the show or Festival, or while they are in the exhibit area. Exhibitor hereby indemnifies and holds the said parties harmless from all such liability, to include all costs incurred in defending any such claims. Exhibitor is responsible for appropriate insurance coverage and must submit to The North Carolina Seafood Festival thirty (30) days in advance of the boat show a copy of the Declaration Page of Exhibitor's insurance policy. If directed to do so by the North Carolina Seafood Festival, Inc., Exhibitor will cause the NCSF to be an additional named insured on said insurance policy. It is acknowledged that Exhibitor is an Independent Contractor and is neither an Agent nor an Employee of the said parties.

**Weather:** Neither shall the parties be liable to the Exhibitor as a result of any losses sustained as a result of inclement weather. Such losses would include, but not be limited to, loss profits or revenues, or physical or property damage. In the event of an impending hurricane or other severe weather condition, the parties reserve the right, in their sole discretion, to cancel the event, and such cancellation shall not create any liability of any kind or nature whatsoever to the Exhibitor or anyone claiming by or through the Exhibitor.
